### THE GMAT IS AVAILABLE THROUGHOUT THE YEAR.

The GMAT is available as both an in-person computer test and a remotely proctored online test. The GMAT Online has the same content and structure as the in-person GMAT.

GMAT administrations should be scheduled once a student is fully prepared to take the test.

Students should check with the schools to which they are applying and then schedule an appointment early enough to allow scores to be reported before application deadlines.

### GENERAL INFORMATION

The GMAT takes three and a half hours to complete, including breaks.

GMAC imposes a lifetime limit of eight GMAT administrations. GMAC does have an appeals process for students who have previously taken the exam multiple times but did not attend business school.

The in-person GMAT may be taken once every 16 calendar days and no more than five times within any rolling 12-month period.

The GMAT Online can be taken up to twice, and it counts toward the annual and lifetime limits.

GMAT scores are valid for five years.

### RECENT CHANGES

Students can select the section order on official in-person GMAT administrations from one of three options:

- Analytical Writing Assessment, Integrated Reasoning, Quantitative, Verbal
- Verbal, Quantitative, Integrated Reasoning, Analytical Writing Assessment
- Quantitative, Verbal, Integrated Reasoning, Analytical Writing Assessment

On April 16, 2018, GMAC shortened the Quantitative Reasoning section to 31 questions to be completed in 62 minutes and the Verbal Reasoning section to 36 questions to be completed in 65 minutes.

### CANCELLATIONS

GMAT Online scores cannot be canceled. Students are able to cancel scores within 72 hours of their completion of the official in-person GMAT for a \$25 fee.

In-person scores can be reinstated from the prior four years and 11 months for a \$50 fee.

Canceled scores can be reinstated up to four years and 11 months of the in-person exam date. Note that it can take up to 20 days for the reinstatement to be processed.

### ACCOMMODATIONS

Disability Services may take approximately three to four weeks to process applications for testing accommodations. Students must apply for and receive an accommodation decision before scheduling a test date. Once approved, students will receive a letter stating the expiration of their appointed accommodations.
